# **East Drayton Parish Council**

Minutes of a Meeting of the Parish Council held at 7.30pm on Tuesday, 18<sup>th</sup> June 2013 in the Village Hall

#### Present:

- 1. Apologies for Absence were received from Cllr R Small and DCllrs K and S Isard.
- 2. Minutes of meeting held on 21st May 2013 were approved and signed.

## 3. Matters Arising

- i) Defects to village roads. The Chairman confirmed that the reflectors on Darlton Road had been replaced, but the Tarmacced drain had not yet been attended to. It was AGREED to contact Jeannie Wallace at the Highways Department to enquire when this will be remedied. **ACTION: S Pickard.**
- ii) Bassetlaw Spring Clean  $(22^{nd} \text{ April} 6^{th} \text{ May } 2013)$  The Chairman confirmed he had completed the task as far as he could due to the height of the grass verges.
- iii) Best Kept Village competition update the Chairman reported some tidying/grass cutting had not been completed, but there had been a general rally round in readiness for the judging (taking place between 3<sup>rd</sup>-21<sup>st</sup> June).
- 4. **Declarations of Interest by Councillors** there were no declarations.

#### 5. Planning

Cllrs had now had the opportunity to read The Guide to Conservation Villages in Bassetlaw for clarification (with particular concern regarding solar panels, satellite dishes and uPVC replacement windows), together with the Conservation Guide for Householders. The Chairman noted that the village envelope had not changed since the 1950s. The Chairman suggested that the next village newsletter includes a note advising parishioners consult with Bassetlaw District Council's planning department when considering extra satellite dishes, solar panels and uPVC windows within a Conservation village.
