I have received the precept request form. Will there be another increase or shall we keep it the same as last year? I have included two budgets, one with the precept remaining the same as last year and the other with an increase of 3.33%, £1.00 per house hold.

5. **Planning**

A66 Highways England – we have received a pack showing areas where surveys are required and amounts of compensation that we can claim.

DM/20/02624/FPA – West of Woodcock Hall – conversion of agricultural building to form residential dwelling

DM/20/02714/FPA – Single and two storey extension

DM/20/02817/FPA – Green Fell View – erection of porch to front elevation and garden room to rear. Cllr Hughes raised a concern with the porch in a conservation area where the only porches facing Front Street and Low Road are on the church, the former Methodist chapel and the school. Woodcock Hall has got a porch but it is not on the same alignment as the other houses. The school has the only porch on the North side of Front Street and to add one to green Fell View would be anomalous in the street scene and stand out quite starkly. I think there is also an issue that, if it were to be approved, others might want to put one on their houses too. I imagine the conservation advice will be to refuse it as being inconsistent with the aims of the Conservation Area. We are waiting to see what the Conservation/Heritage officer says.
