1. To approve Minutes

Community Submissions

Reiner Struck said the Litter Pick had been very successful with thirty people attending. He also thanked the Clerk for providing the posters.

John Lovelock was asking the possibility of some form of traffic calming at the One Pin as there have been several more traffic collisions. Mrs. Foggoa also commented on the traffic collisions which have continued to happen at the One Pin. TB again repeated his answer from previous times that it was the drivers, not the road which caused the problems.

PL/26/03771/FA The Yew Tree, Collinswood Road, Hedgerley

The Parish Council discussed this application at its meeting on 18 June 2026 and agreed that, what is described on the proposed elevation plan attached to the above application, as “extend existing roof” on the proposed extension should be reduced in size so that it does not visually intrude on the view from the road as show on the front elevation in the plans.

By reducing the size of the proposed roof extension it would be possible to retain the existing balanced appearance of the frontage of the former public house.

PL/26/04549/FA Cottage Park Road, Hedgerley

The Parish Council discussed this application at its meeting on 18 June 2026 and agreed that, as the proposal closely resembles similar extensions on neighbouring properties, no objection should be raised.
