We had an impromptu meeting in Coppice Way this afternoon with Ben, John and myself, concerning the fence on the left hand side as you drive into Coppice Way.

Not only are a significant number of posts now broken but it appears that a number of cross pieces have been deliberately broken by vandalism. Ben's advice is that it would be best to replace the whole stretch of fencing, which includes approximately 12 posts.

We understand this would need to be put before and agreed by the Parish Council and would ask please that you include this piece of work on the next agenda. We would of course appreciate the work being completed as soon as possible and then the residents of Coppice Way would paint the new fence.

The fence has been temporarily repaired over the course of the past few years and now beyond further repair. The fence painting is down for being done on 1st August.
