Minutes of the meeting of Cerne Valley Parish Council held at 7.30pm on Thursday 14th March 2019 in Cerne Abbas Village Hall

1. Apologies for absence

Cllr's Bolt, Horsington, Lister and Beresford along with Haynes (DCC) and Yarker (WDCC) sent apologises.

2. Declarations of pecuniary and other interests

No matters were declared.

3. To confirm the minutes of the Parish Council Meeting held on 10th January 2019

These were agreed as a true and accurate record of the meeting and signed by the Chairman.

4. Issues arising from previous meeting

It was confirmed the toilets would remain open and managed by the new Dorset Council for the next year.

The tree in the Snicket had been removed.

BT are to repaint the telephone box in Cerne Abbas

5. Update from the Chairman

The Chairman wished to thank all members of the Parish Councillors the hard work put in during this term of office. Further gratitude was given to those who were not going to stand for election in May 2019.

6. Public Discussion Period

Concerns were raised as to the inconsiderate parking in Abbots Walk. The Chairman stated that a Parish Council had little power in these matters.

It was agreed to write to business of the silver Mercedes van in question and contact the PCSO. It was suggested that because it was a NHS vehicle, that the surgery may allow overnight parking there.

Mr Roy Burnham spoke on the tourist leaflet which had been redesigned. It request that a grant be given towards the reprint costs.

The Parish Councillors unanimously agreed a S106 grant £100.

Mr Burnham also thanked the Parish Council for yellow lines on Long Street. However, he observed that individuals still parked on them.

Cllr Furness updated the Council that the EA had finished their work which included some tree maintenance near the dam. Consideration was being given to lighting in the car park.

<u>Play Park</u>

Cllr Furness spoke on the latest inspection report which had just been received. He would try and facilitate these repairs at the earliest opportunity. He also requested that the play equipment had a spring clean jet wash.

This was approved.

Footpaths and Environmental matters

Cllr Keating confirmed he had received 2 quote for the maintenance and pruning of the Lady Elkin garden. He requested what the Parish Council would like to do. **It was unanimously agreed to pay for the works in full on a one times basis.**

11. Recruitment of new Parish Councillors – May 2019

12. Request for website upgrade funding from Cerne Valley Business Group

Mr Roy Burnham, on behalf of the CVBG, requested a grant towards the upgrade of the website.

The members agreed that the website proved value for money and approved a grant of £350.

13. Request for flagstone on Long Street

A complaint had been received about a pot hole on the pavement on Long Street. The hole had been fixed by DCC Highways but they recommended that a flagstone would secure the site for many years to come.

The Parish Council agreed that pavement repairs sits with DCC Highways and must remain that way.

14. Giants View Car Park – proposal and discussion

Cllr Barry updated the Parish Council on the meeting with DCC Highways regarding making the area safer for coaches to park. Cllr Humphrey's, on behalf on some residents, raised concerns that this could have a detrimental effect on the impact of the quality of life for parishioners if many more coaches stopped.

It was agreed to await the conclusion of the DCC Highways team but raise the matter of potential increase in tourists at the village meeting.

15. The Giants Trail – proposition and discussion

Initial discussions had been had on reinstating the Giants Walk and Heritage Trail in Cerne Abbas. This would include route markers and notice board, the route going from the car park to the kissing gate near the giant and coming back via St Augustine's Well, the Abbey and Long Street.

Councillors seemed happy with this proposal and approved the proposition to be xplored further.
