Why do we exist! We are a Special Purpose Vehicle for a Private Finance Initiative Contract with Nottinghamshire County Council (NCC)

Contracted to the County Council for 26 years 10 months to accept and recycle/recover and/or dispose of Household Waste generated by the residents of Nottinghamshire

Started April 2006 contract signed June 2006. Due to finish March 2033

Contractual requirement to fund capital investment in new and existing facilities, move away from being landfill dependant.







Veolia in Nottinghamshire

Since 2006 Veolia has been helping Nottinghamshire County Council and the seven Borough/District Councils of Nottinghamshire to manage household waste created in the County.

Over the life of the 26 year Private Finance Initiative (PFI) waste management contract, we will help to increase household recycling and composting in the County to 52% by 2021; significantly reducing the amount of waste going to landfill.

We directly manage the following facilities:

- Mansfield Materials Recovery Facility,
- Newark Transfer Stations,
- Worksop Transfer Station
- Giltbrook Transfer Station
- Welshcroft Close Refuse Derived Fuel Facility,

We also manage Nottinghamshire's 12 Recycling Centres which are ran by separate contractors.









12 Recycling Centres and other Recycling

Nottinghamshire's 12 Recycling Centres

These centres currently receive around 90ktpa of waste and recycling.

Over 90% of this is recycled annually,

The sites take a large range of recyclables, inc, Green Waste, Wood, Electrical Items, Scrap Metal, Card/Paper, Batteries, Oil

Open 362 days per annum with hours varying according to seasons.

Street Sweepings

Since 2006 we have accepted street sweepings across our sites that we send on for Recycling. Currently we recycle c7-8ktpa










The Materials Recovery Facility

The Mansfield MRF £14m facility was designed to process co-mingled paper, cardboard, plastic bottles, yoghurt pots and margarine tubs, food and drink cans, and aerosols.


The Facility can take 85ktpa of the above materials. Currently the WCAs deliver c47ktpa so there is plenty of capacity. Currently we estimate that there is c20% (inc Glass) of material that could go to the MRF in the residual bins.
