## 1. To approve Minutes of Meeting dated 14th May 2018

Proposal for extra parking spaces at top of Holt

The initial suggestion from ML was for four spaces. As the drawing which had been provided was not to scale, it was evident that this idea would not be a viable one. ML has suggested for cars to be parked as they do already, butted alongside Church Meadow. Further discussion will have to be done.

• Gatepost at bottom of the Holt.

As it was not possible to install a new post in either of the holes because of power cables running underneath. The only option was to ask PCC if they still wanted the gates in place or for us to remove them completely, or move both posts and gates, but owing to the limited space it could prove difficult. Clerk to speak to PCC.

• Flooding at the Holt

With the continued problem of the rain washing debris down the Holt, Councillors agreed that something has to be done to remedy the situation. Before any further action, Clerk has to find out who is actually responsible for the Holt.
