## **East Drayton Parish Council**

Minutes of a Meeting of the Parish Council held at 7.30pm on Tuesday, 21st April 2015 in East Drayton Village Hall

- 1. **Apologies for absence** were received from Cllr A Stanley, Cllr H Mackintosh and PC Bailey.
- 2. Minutes of meeting held on 10<sup>th</sup> March 2015 were approved and signed.
- 3. **Declarations by Councillors of any disclosable pecuniary interest(s) in any agenda item -** Cllr Small declared an interest in Agenda item 5i) Planning and this matter was moved forward and debated before his arrival to the meeting.

#### 4. Planning

i) Location: Plot 3 Ashlea Farm, Low Street, East Drayton. Proposal: Erect two storey detached dwelling (previously approved under PA 15/09/00002) with the addition of a single storey rear extension: Application No: 15/00308/FUL. The Council had no objections. **ACTION: S Pickard.** 

Cllr Small joined the meeting. An entry was made in the Declaration of Interest book and duly signed.

- i) Footpath to the side of St Peter's Church The Chairman confirmed that Laura Summers, Rights of Way Officer at Notts CC would action this tidying work in the new financial year; ie this month onwards.
- ii) Village drains blocked on Low Street Cllr Goddard reported this had still not been attended to and the Chairman AGREED to contact Johnny Davis. **ACTION: The Chairman.**
- iii) BKVC plaque in the village hall a sign writer had not yet been found to update the plaque. To be retained on next month's Agenda.

#### 7. General Business

- i) Parish Council The Chairman confirmed this had been an uncontested election for East Drayton Councillors and all will serve four years. The next full parish council elections will therefore take place in 2019. The Chairman reminded Councillors re the expenses return form. The Clerk added that all Councillors will be required to complete new Register of Interest forms at next month's meeting.
- ii) Planters (purchased from BKVC prize money). Siting suggestions were discussed: a corner of the village hall car park/on the island or in front of St Peter's Church where the salt bin currently stands. Cllr Stephens offered to source a supply of compost.
- iii) Traffic calming The Chairman advised that EDF Energy has secured funding for an interactive speed sign for the village. The funding is currently in the process of being transferred to Nottinghamshire County Council, who will in turn, contact the Parish Council to discuss installation. The Chairman added that for the price of the large sign they could have four of the smaller ones as mentioned previously by Cllr Mackintosh on the road down to the Council tip. The Chairman thanked Mr David Stone for his help in the matter.
- iv) Purchase of mower for PCC Community Grant from DCllr Keith and Shirley Isard; the Chairman confirmed the mower had now been purchased.
- v) Eon phone kiosk electricity the Clerk advised that with effect from 1<sup>st</sup> May 2015 a Deemed Contract would mean a rise from £20.48 annually to around £28 (first increase in price for nine years). Cllr Stephens commented he had seen a phone box being utilised as a seed bank, as an alternative to a book exchange.

#### 8. Meeting adjourned for Public Discussion

a) Mr David Stone said he had primarily attended the meeting for an update on the speed signs. He felt the sign already secured should be placed on the busiest road, but agreed that four of the smaller signs would make quite a show and cover all the village roads.

#### 9. Finance

Ltd regarding purchase of mower for the PCC. ACTION: S Pickard.

v) The Council APPROVED payment of £4.00 to CPRE (Notts) Branch being entry fee

to the Best Kept Village competition. ACTION: S Pickard.
