Council accepted the minutes as true record of business.

Police Report

316. Council reviewed the report.

District and County Councillors Report.

- 317. Unitary authority. Cllr Mike Rigby updated the council on local government reorganisation: the unitary Somerset authority, plus local community networks (LCN). The LCN are designed to bridge the gap between parish councils and the unitary authority. Their size / boundaries have yet to be decided. The unitary is due to 'start' on in April 2023, but local elections (delayed by COVID) are due in May 2022. No information yet on whether those elections will be postponed again. There will be fewer Councillors on the unitary, but a greater workload. How to ensure the role attracts a mixed-age cohort, i.e. working-age people as well as the newly retired?
- 318. Phosphates. The new statutory duty to mitigate phosphate discharge from housing development has created a moratorium on house building in the Tone catchment. There are 2,500 homes waiting on a solution, which threatens SW&T's ability to meet its obligations, opening the door to development of other sites. The solution: Wessex Water needs to accelerate upgrades to its treatment plants. SW&T could potentially help fund this and recoup costs from developmers.

Matters Arising.

319. Play park. The Clerk has instructed a contractor to resurface the area around the swings. Council noted that the black material around the climbing frames stains clothes because it wasn't sealed correctly. Council suggested re-sealing (an hour or two's work) once the park is less heavily used in the

winter. The basketball hoop is also nearing the end of its life. Should it be replaced like for like, or with something with else? Cllr Clothier to research options.

- 323. Queens Jubilee. Proposal to put a new bench in the playpark. Cllr Taylor investigating. Plant a tree either side? e.g. apple and flowering cherry. Supplementary: should we be thinking about a larger village fete / fair during the Jubilee (Thursday 2nd to Sunday 5th June.) Tbd at next meeting?
