1. Apologies for absence: apologies accepted from Mr T Ozbourne

2. Declarations of interest:

Mr C Allen declared a personal interest in Item 6

3. Minutes:

 Minutes of the meeting of 23 October 2014 accepted as a true record. Proposed by Mr C Allen, seconded by Mrs V Wright and accepted unanimously by those present at the meeting.

4. Progress reports (for information):

- a) Street Lights A good number have been reported with only 2 currently outstanding
- b) Trees/Hedges Spoken to or written to as many landowners/tenants as is possible. All agreed that this is passed to Nottinghamshire Highways if no action has been taken by the next meeting
- c) Sand Bags The fire station have agreed to store the sandbags and the order has been placed with Nottinghamshire County Council
- d) Dog in the Community Park Letter was sent to the resident walking their dog through the park he did apologise and stated that he had not seen any signs prohibiting this. Due to ill health he had been taking the shortest possible route but will soon be getting a scooter and will therefore no longer need to take this route
- e) Newark Hospital Campaign Following the public meeting on Monday, individuals to write letters on this matter. Names and contacts to be provided as to who these should be sent
- f) Neighbourhood Watch There has not been any activity on this and the police believe the scheme to have been closed down. Mr M Dowell says there has been no action from the police. 15 volunteers lined up and waiting once contact can be made with the police.

5. Report from County and District Councillors:

Cllr Mrs M Dobson:

 Train Station Parking – a meeting is to be held at the memorial hall, date to be confirmed Tues 9th or Thursday11th December for residents of Station Road. Mrs Scott said she considered a member of the Parish Council should also attend.

- A1133 following an internal audit by Notts County Council Mrs M Dobson is trying to get the road closed to heavy traffic between 7pm and 6am. This is made difficult as part of the A1133 is in Lincolnshire
- Boundary Change Mrs M Dobson asked for numbers to be reduced, but was over ruled. The decision was made by NCC to maintain the status quo
- Spending proposals, please keep Mrs M Dobson included in any correspondence from the Parish Council
- Bus stops at the top end of the High Street were on the agenda for a decision by the Parish Council
- Greenwood Tree Grants, Mrs M Dobson will see what she can get organised
- Winthorpe and Besthorpe Youth Clubs are up and running. A junior group to be set up in Collingham in the New Year

Cllr Mr R Shillito NSDC:

- Horses have been left untied on Hewson Lane and Westbrook Lane for fly grazing and as a result there have been two killed on the railway line. The fences have now been repaired by Network Rail to prevent this happening again. There is no link between the land owner and the owner of the horses. The horses are being cared for by the owner, but are not tethered. The local Beat Team are aware of the problem.
- Newark Hospital meeting was well attended
- Noted the appeal for 7 Station Road
- Attended the men in sheds open day and was impressed
- Pleased to see something is in progress about the parking situation at the station car park
- Mr Shillito had received a set of crime figures from a meeting with the Police Commissioner and another set of figures from NSDC. He considered that incidents are not going down, crime is actually going up

Cllr Mr M Shaw NSDC:

 Queried how are the residents of Station Road going to find out about the residents meeting for the waiting restrictions on Station Road/Station Close. This is a matter for Nottinghamshire County Council, but the Parish would anticipate this would be via letter.

Brenda and Tim Musson were thanked for their fundraising for the defibrillator fund

Transfers/Authorisations

- Authorisation for the Clerk to be permitted to register and use internet banking. Proposed by Mr T Musson, seconded by Mrs C Moody and agreed unanimously
- Amendment to the 10 July Finance Meeting Item F6 now to read: agreed that £260 (donation) be transferred to the **Defibrillator** reserve. This now reflects the actual amount transferred and to which reserve it is for. Proposed Mrs M Parkin, seconded by Mrs C Moody and agreed unanimously
- Transfers of:
 - £44,750 from the **Reserve** Account to the New **Park** Account this is the Agreed £53,000 minus £8,250 match funding already paid to WREN
 - £43.41 from the **Current** Account to the New **Park** Account these are 2 small donations given for the park
 - £9,489.50 from the **Current** Account to the New **Park** Account this is 50% of the Fields in Trust Inclusivity Grant received
 - £3,520.00 from the **Reserve** Account to the New **Park** Account all donations received (Brownies, Skin and Tonic, Bonfire (last year),etc)
 - £2,000 from the **Current** Account to the **Reserve Account** which was transferred in March to cover all outgoings
 - £750.00 from the **Reserve** Account to the **Current** account

Proposed by Mr C Allen, seconded by Mrs C Moody and agreed by majority. Mrs M Parkin abstained from the Park transfer, but was in agreement with other transfers.

- The bonfire organisers raised around £1600 and wanted to put this to a defibrillator for the village. Discussions were held about locations in Collingham, so far William Bailey House and Fire Station have been agreed as locations with the building owners. A third location has been suggested for the cricket field, which would be available to all the sports clubs in that area and local residents. The football club would also like a defibrillator but this would not be open to public access as the ground needs to be secure when not in use.
- Authorisation to change cost code "26 Current Account interest" to "26 Reserve Accounts Interest". Proposed by Mrs R Scott, seconded by Mr T Musson and supported unanimously
- To agree that the Capital Revenue Reserve Account interest is paid into the Current account, which would replicate what occurs with the Reserve account. Proposed by Mrs C Moody, seconded by Mrs M Parkin and agreed by majority
- Bank Reconciliation for the year to date signed by the Chair of Finance
- Practitioners Conference Training event for Clerk. Proposed by Mrs V Wright, seconded by Mrs M Parkin and supported unanimously £235 + travel

8. Collingham Community Park

a) Proposal to appoint Hags-SMP as contractor for the play equipment at a cost of £132,254.00 – proposed by Mrs R Scott, seconded Mrs V Wright, agreed by majority

- b) To nominate contractors to submit quotations for the supply and fitting of fencing to two sides of the Community Park, with DDA compliant gates and entry surface. (Gates and surface to be paid for by Fields in Trust Grants). Contractors agreed: Doug Lyne, Fleet Fencing, North Notts Landscaping. Mr Dove would give the Clerk details of another local contractor. *Post Meeting Note: HTW Fencing*
- c) Update on other work to complete refurbishment of Community Park. The probation service and the unpaid workers scheme may do some of the removal works of existing play equipment. Landscaping was being designed by member of Play Park Committee and grants/sponsorship being investigated. The site will be kept secure during the works. Mrs R Scott and Mr C Allen met with an A level student to discuss refurbishment of the skate park. Notices will be erected to explain this element, so that skate park users are aware of the background to the work.

9. Youth and Community Centre

To nominate contractors to submit quotations for refurbishment of exterior of Centre. Work to include:-

- replacement of flat roof over toilet block with longer lasting covering e.g. fibreglass
- increase pitch of roof
- insulation in ceiling
- · associated internal repairs and decorations

10. Correspondence:

- a) Nottinghamshire County Council Electoral Boundary Review. Write and say the interest of all villages should be taken into account
- b) Local Government Boundary Commission Review. As above
- c) Greenwood Community Tree Planting Grants. To be sent to the Community Orchard and Community Park Committee
- d) Influencing Policing in Your Area. This is undertaken by SNG and has been circulated to all village contacts
- e) Bus Stops High Street/Woodhill Road, proposed relocation by Nottinghamshire County Council. The new location is as suggested by the Parish Council, this is therefore supported
- f) Nottinghamshire County Council Consultation on Spending Proposals. It was agreed that individuals would make their own comments, but that the Parish Council would write to NCC requesting that the DEFRA Rural Proofing Guidelines (as detailed on the DEFRA website) were followed, so that rural communities were not hardest hit by cuts
- g) Community events to commemorate the great war. The History Society are discussing a project to mark the end of the war
- h) Delivering Differently in Neighbourhoods information for Parish Councils. No discussion of this had taken place at NSDC yet so further information would follow at a later date
- i) Grant Application from Collingham Memorial Hall. The agreed policy of the Parish Council Section 137 grants require that an application form is completed. The Policy and form will be sent to the Memorial Hall
- j) Station Road and Station Close Proposed Waiting Restrictions by Nottinghamshire County Council. Some of the restrictions do not appear to be the correct solution to the problem The meeting for the residents will cover all of the issues that have been raised so far. The At Any Time restriction is completely inappropriate in that location. The restrictions on Station Close were supported. The Parish Council will write to Network Rail/East Midlands Trains requesting that car parking is free at Collingham as has already happened at Ruskington, Metheringham and Hykeham in Lincolnshire.
- k) Adoption Notice for Design SPDs from Newark and Sherwood District Council Noted
