- (d) Neighbourhood Plan: Once any changes have been made by TWC as recommended by the examiner it will go to referendum. Points to note, SLA was rejected, the Croft was rejected as a green space as was the plant nursery by the allotments.
- **(e) Footpaths:** The Council was informed that an upgrade of the pavement in Whitegates was unlikely at least until 2020 through TWC pride in your community.
- **(f) Bus Shelters:** A fault with the light in the bus shelter on Church Road had been identified and made safe by Western Power. It was thought that historically these lights had been disconnected.
- **(g) Street lighting:** A number of street lights which were not working on Nursery Lane and Adjoining roads have been dealt with by contractors. It is highly likely that works to upgrade the street lights within the Parish will take place during November / December this year.
- **(h) Newsletter:** Discussion was had on what could be included in the Newsletter with Cllr K. Cherrington to be the lead on this project.
