232/23 APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors Daly, Ecclestone, and Karling.

233/23 DECLARATIONS OF INTEREST

There were no interests declared at the meeting.

234/23 MINUTES

Councillor Drakakis-Smith requested that her objection to Minute 215/23 Planning Matters be recorded in these Minutes.

235/23 PUBLIC FORUM

There were no Members of the Public in attendance at the meeting.

236/23 STAFFORDSHIRE POLICE

In the absence of a Police representative, Members discussed the crime statistics.

237/23 REPORTS

The Members received the following reports:

(i) The Chair

Councillor Bettley-Smith submitted his apologies for the October meeting, as he was unable to attend due to family commitments.

On behalf of the Parish Council the Chair extended thanks to Laura Lee for her contributions to the Parish Council finances, from her book sales.

Discussions ensued regarding the street naming of the development on land off Main Road, Wrinehill, and the Clerk explained that Standing Order 26 had been followed to address this matter.

(iii) Representatives on Outside Bodies

Councillor Bullock updated Members on discussions with the police over a recent road traffic accident. He expressed disappointment that there was no police representative attending the meeting.

238/23 FOOTPATHS WORKING GROUP

Councillor Berrisford updated Members on the progress made to the footpath improvements. She reported very successful outcomes from working closely with various landowners, to improve footpath links which now extended beyond the Parish.

In order to encourage young people to participate in this scheme as part of their Duke of Edinburgh Award, Councillor Berrisford agreed to advertise the scheme on the Parish Notice Boards.

Silhouettes would be erected on the Memorial Garden, on the day that the Poppy Appeal was launched.
