

# Ivinghoe Parish Council

## Minutes of the Ivinghoe Parish Council Meeting held at Ivinghoe Town Hall on Monday 7<sup>th</sup> March 2022 at 7.15pm.

### **C/044/22. Chairman's Welcome.**

The Chairman opened the meeting and welcomed everyone.

### **C/045/22. Public Question Time.**

### **C/046/22. Apologies for Absence.**

Apologies were received from Councillor Bexson.

### **C/047/22. Declarations of Interest or Dispensations from Councillors Relating to this Meeting.**

Councillor Groom declared an interest in planning application Town and Country Planning Act 1990 appeal under section 78 – Land between The Warren and Middle Path Farm, Tring Road, Ivinghoe, Buckinghamshire LU7 9EJ. ### **C/048/22. To receive Reports from the Buckinghamshire Councillors.**

Councillor Town had circulated a report prior to the meeting and there were no comments.

Councillor Brazier thanked Ivinghoe Parish Clerk for organising the photoshoot for Ivinghoe Parish Council, 130 people attended to support the Ivinghoe Freight Strategy Zone.

Councillor Brazier spoke about The Proud of Bucks Community Board Award. The award is given to people who have greatly contributed to the local community to improve the lives of others. This year the award was very competitive, the runner up was a lady in Wingrave who is very active in her local community especially during the Coronavirus pandemic. Councillor Brazier announced that the winner this year is Ivinghoe resident Frances Booth and thanked everyone for their nominations and all the support received for Frances Booth. The Chairman agreed that Frances Booth's award is well deserved. The Chairman thanked the Ivinghoe Parish Clerk for her work on this.

### **C/051/22. Highways, Streets and Transport (including Lighting and Speedwatch).**

The Chairman thanked Bucks Councillor Brazier for organising the footpath clearance in Ford End.

Ivinghoe Aston street names. Councillor Lott explained that the road name is incorrect on Google Earth. It was agreed to submit an article into the May issue of Ivinghoe Beacon Magazine to ask residents what they would like the name of the main road to be. Councillor Ketteridge will also help publicise this on Facebook. Ivinghoe Freight Strategy Zone – no update.

Ivinghoe MVAS repair – this will be passed to Councillor Brazier to fix.

### **C/052/22. Footpaths, Bridleways, Trees, Playgrounds and Parish Events.**

Russell Smith addressed the Parish Council about the Village Fete. A number of stakeholders including St Mary's Church, Ivinghoe and Pitstone Scouts, Ivinghoe and Pitstone Women's Institute, Pitstone allotment society and potentially Windmill Pre-School could all be involved in the fete and have the opportunity to fundraise for their groups. It was agreed to allow the fete on Ivinghoe Lawn on Saturday 25<sup>th</sup> June free of charge.

Ivinghoe Lawn Bylaw – Councillor Lott read the 1977 bylaw for Ivinghoe Lawn. Councillor Lott explained that the bylaw cannot be used as a Car Park. Occasional parking is allowed for Council business and with permission of Ivinghoe Parish Council.

It was agreed to ask Edlesborough Parish Council if they would like to take over the bridleway IVI22A/EDL/20/1.

Blue Coronavirus signs – it was agreed to remove the signs. Buckinghamshire Smoke Free Zones – public health services are asking parish councils to promote smoke free areas. It was agreed to order no-smoking signs for the Ivinghoe children play area as this is separate to the rest of Ivinghoe Lawn – Councillor Lott to research.

Ivinghoe Aston Lay-bys – a site visit will be arranged with a potential contractor and Ivinghoe Parish Clerk will contact the Local Area Technician for his view.

HM The Queen Jubilee – Ivinghoe Parish Council will buy and plant two mature trees one for Ivinghoe Aston and one for Ivinghoe as part of the Green Canopy. Councillor Ketteridge will ask the views of the residents in Ivinghoe Aston regarding the location.

AboveBelow Festival will be held over the Jubilee weekend, Councillor Ketteridge will let the Ivinghoe Residents know about the festival arranged for the 2<sup>nd</sup> – 5<sup>th</sup> June 2022.

**C/053/22. Boundary Commission for England Review.**

Vice Chairman Councillor Bamber explained about the possible changes to the boundary changes. Ivinghoe could be part of the Aylesbury constituency. The deadline for commenting is the 4<sup>th</sup> April 2022. Residents are encouraged to make comments on this.

The Parish Clerk will write to a plot holder to ask them to remove the Ash tree that has been allowed to grow.
