2164. Apologies for absence.

2170. Complaint re Planning

The Council has, on a number of occasions, raised its concerns regarding the inconsistencies in the local planning regime particularly in connection with enforcement. Councillors **AGREED** that they wished to raise a formal complaint with West Northamptonshire Council in relation to planning, and asked the Clerk to prepare the complaint and circulate before submission

2171. Highways and Footpaths

<u>Handyman</u> – The Clerk reported on the work that the handyman had completed to date and that she would remind him of the work in preparation for Remembrance Day. <u>30MPH</u> Limit. The Council had been consulted prior to the legal order being prepared and advertised. The Council's request for an extension west bound in Upper Stowe had been accepted and the Clerk was advised that the work would be completed within the current financial year.

There was a discussion about the Highways contract for grass cutting on the 'gravel path' and Cllr Overton agreed to report the issue on Fix My Street as she had been cutting back the nettles herself.

2172. Community Defibrillators.

Replacement Charger packs and pads, for both defibrillators, had been purchased and installed. Sam Callear was now carrying out the checks on the Upper Stowe Defibrillator, and Sharon Henley had offered to take on the checks in Church Stowe as and when Jo Dickson leaves the village.

The Clerk would be liaising with the Community First Responders Team to arrange another training session.

2173. Historic Memorials

The WI would be arranging a display of knitted poppies along the fencing at the Old School Rooms and the War Memorial in time for Remembrance Day.

Tony Sanderson had been in contact with the RAF Air Defence Radar Museum regarding putting a photograph of the local Radar Memorial into their display. He had offered to check the feasibility so that the Parish Council could then formally request its inclusion. Councillors **AGREED** to submit a formal request once Mr Sanderson confirmed that this was the way forward.

2175. West Northamptonshire Council.

Community Governance Review – the Parish Council had an opportunity to take part in the Community Governance review which could consider changes to the parish boundaries or the status of the Parish Council. Councillors **AGREED** to ask if a council <u>could</u> revert to being a parish meeting and, if that were possible, what the process would be.

2176. NCALC.

The NCALC AGM was taking place at Moulton Community Centre on Saturday 7th October at 10.00am, and the Parish Clerk would attend.

2177. CPRE

Councillors were asked to consider if they wish to renew the Council's membership of CPRE (due 1st December - £36.00) which continues to provide updates of its campaigns on behalf of rural communities. **APPROVED**

2178. Website and Email

Parish Councils have been advised that they should have a gov.uk domain name and that Councillor e-mail addresses should be controlled by the council rather than through a commercial provider (e.g. yahoo or gmail).

Parish Online had provided the following quotation:- 'We can apply our Existing Customer discount to make your annual subscription £320 ex vat. That discounted price will stay with your account each year of your subscription. Also, as an existing Hugo Fox customer, we can defer your subscription payment until the next accounting year if that helps.

The subscription includes the build, hosting, ongoing maintenance, SSL certificate, support, 20 email mailboxes (through webmail and IMAP) and the cost of the gov.uk domain.'
Councillors **AGREED** to proceed with this quotation.
