16.103 PLANNING APPLICATIONS

The Committee made the following comments on the Planning Applications:

- i. **27211/003.** Single storey extension to side following demolition of existing garage. Langtons Piece, Stancomb Broad Lane, Medstead, Alton, GU34 5QD. **Medstead Parish Council have reviewed the details of the application and have no objection.**
- ii. 56157/004 Lawful Development Certificate for Proposed Development Three outbuildings comprising a garage/machinery shed, a storage garage, and a pool house/gym building, the laying of a tennis court within the curtilage of the dwelling house, and the laying of hard standing. Medstead Parish Council has serious concerns about the proposed over development of the site. However, should the planning authority be minded to grant permission, we would wish to see a condition attached restricting the use of the storage and repair facilities to personal and non-commercial usage only.
