- 4. Report by West Devon Borough Councillor:**

- 5. Past Subject Matters for further discussion:**
 - 5.1 [5.2] Village Green: After receiving the Parish Council letter the pub landlord again contacted Lord Iddesleigh to circumnavigate the wishes of the custodians of the green; the Parish Council. He now has permission to place tables on the green for the next couple of years to the detriment of the area. However, the Parish Council have two new memory benches on order and these will be concreted into position [as the others are] when received.
 - 5.2 [9.2] War Horse statue: The clerk had phone calls from the Jennie Scott asking where the finished statue will be sighted. She wanted a meeting with the Borough Councillor to discuss this. I explained that the Parish Council had already made arrangements with Councillor Ward that it would be sited at the War Horse Museum. She has not got her funding through yet and as the council agreed she should not have begun the work until she had received the funding. The clerk will contact the Borough Councillor who is supposed to be sorting the grant.

 - 6.1 War memorial: Contact Andrew Gist again to ask for a report on the state of the memorial and the cost of cleaning and repairing if required.
 - 6.2 Trees on the Green: The Council are concerned about one of the trees and has already contacted a tree surgeon but have not received a reply. The clerk will write again.
 - 6.3 Temporary Prohibition of Through Traffic: The pub has received permission to close the road outside for their August festival.
