As a Parish Council we view the reissued Delivery Management Plan as a piece of fiction with glib assumptions that it reduces the effects on Cosgrove Village.

As the clerk here for more than 27 years I/We have never been advised about deliveries. We would also ask MKC to refer to the 14-17 November 2000 Appeal and the Inspectors decision on the Park The appeal conditions appear to have been watered down over time to the detriment of Cosgrove village and its residents. Cosgrove Caravan Park continue to be a poor neighbour and although joint meetings have been held with the promise of a Park Management Plan which has never materialised. We are left with nothing other than drip- drip and piece meal development that MKC appears unconcerned about as the effects on Cosgrove appear not to be their problem or concern. It is hoped that if permission is give now, or in the future that MKC consider the dire affects any further expansion has on Cosgrove village. We are happy to meet and discuss these issues and repeat previous liaison meetings in the hope of an acceptable outcome or compromise can be found
