10. HS2

HS2 are due to close the A423 over the weekend 11th and 12th November 2023. There will be traffic lights on the A423 during the week. 11. Windmill Lane

The planning application 23/01027/FUL went to Planning Committee on 25th October 2023. The Parish Council thanked Cllr Groves and District Councillor Ostrander for presenting their objections to the Planning Committee.

The Planning Committee were unable to reach a decision and requested further information be obtained via an Equine Specialist, consequently the application was deferred.

Cllr Ostrander advised the Planning Team Leader is in the process of formerly engaging an independent consultant.

The report will be made public on the application file and the case will go back to Planning Committee if SDC are still minded to grant the application.

12. Development within the village

12.1 Housing Needs Survey

Sarah Brooke-Taylor from Warwickshire Rural Community Council (WRCC) gave a brief explanation as to what a Local Housing Needs Survey is and how the survey is used by Local Authorities. The same survey is used nationwide to provide a consistent approach and results, all of which are sent to DEFRA and the Government. There are currently 6 households, within Ladbroke, who are registered on Stratford District Councils Housing Waiting List. There is no charge to the Parish Council for the survey to be carried out.

It was proposed by Cllr Groves, seconded by Cllr Holloway and **RESOLVED** a Local Housing Needs Survey be undertaken by WRCC.
