Questions raised included a query in the report issued by the newly formed Mildenhall and Lakenheath Airbases Group; low flying aircraft coming across the town.

Police report: Crime figures for Brandon April 2015 were circulated at the meeting. In the month of April 2015 there have been 34 recorded crimes in Brandon. This compares with 63 crimes the previous month and 34 crimes for the same month in 2014. Questions to Sgt. Tully included the vandalism to the skate park at the BRPF; an assault in George Street car park and whether the CCTV was operational; cyclists going through red lights; the one way system on Thetford Road; a van, static parked on the Highway; whether shops on the High Street selling alcohol have an appropriate licence?

Cllr. G Hughes reported there is to be a change to the Safer Neighbourhood Team priority setting process. A more responsive and flexible system will be put in place. Both the Crime Prevention Panel and Town/Parish Councils will receive updates on the priorities and how they are tackled.
