

## **East Drayton Parish Council**

Minutes of the Parish Council meeting held at 7:30pm

on Tuesday 21<sup>st</sup> March 2017 in the Village Hall

**8. Meeting adjourned for public discussion** –CCllr John Ogle reported on the following issues:

- Policing – Notts Police Commissioner Paddy Tipping attended a meeting called by Tuxford Town Council regarding the future of local policing after the retirement of PC Bill Bailey later this year. The Commissioner, MP Robert Jenrick and Chief Inspector all agree the area needs a local policeman. The suggestion seems to be he would be replaced by Specials. The MP is not happy about this and has requested a like-for-like replacement. Members of the public should write to the Chief Constable/Chief Inspector to express their concerns over the future of policing in the area.
- Clarification that the Children's Ward at Bassetlaw Hospital is not closing, but admissions are not now taken overnight. This is due to a lack of paediatric cover for night shifts. Children requiring admission after 7pm will go to Doncaster or Sheffield.
- Village Gateways – name signs, lines, chicanes, speed restriction signs etc. being used to denote entry to villages and reduce the speed of traffic.
- SCR – Cllr Greaves still pursuing this but our MP does not expect this region to go into the Sheffield City Region. Long term policy is a Unitary Authority in Nottinghamshire.

- Cllr Ogle was thanked for attending the meeting and explaining progress on the above matters.
