### **5 a) Chair's Report (Paul Kelly)-**

Two items for discussion in my absence.

1.Membership fees for 2025. My view is to leave the same. We have a sufficient cash reserve to fund our one-off items of refurbishment.

2 Question to ask members at AGM renewal of Green Edging boards. Renew like for like with Tanalised timber, last replacements sections failed at 5 years. Renew with recycled plastic timber planks life expectancy 25 years plus.

Like for like Timber cost 100mm x 30mm £2.80 per metre x 80m (one side of green)

£224.0 £1000 to replace all edges.

Plastic Timber 100mm x 30mm £7.00 per meter x 80m £560.00 £2240 to replace all edges.

Plan would be to replace two edges in year one and two in year two whichever material is chosen.

The plastic planks while dearer in the first instance is cheaper over 25 years as you would expect to replace the timber at least four times. While installation is free as undertaken by the green team replacing once over 25 years is a significant time saving and work effort.

Either option has the additional cost of Astro turf facing material which is currently £200.

You may wish for the exec to support one option and put it to the members.
