# MINUTES OF THE COLLINGHAM PARISH COUNCIL MEETING held at 7.30 pm on 26 MARCH 2015 in the YOUTH & COMMUNITY CENTRE, LOW STREET, COLLINGHAM

**1. Apologies for absence:** apologies accepted from Mr C Allen. No apologies were received from Mr M Dowell, Mr T Ozbourne.

#### 3. Minutes:

- Minutes of the meeting of 26 February 2015 were agreed. Proposed by Mrs C Moody, seconded by Mrs M Parkin and agreed unanimously by those present.
- Minutes of the Annual Parish Meeting of 12 March 2015 were proposed by Mrs M Parkin, seconded by Mrs V Wright and agreed unanimously by those present.

#### 4. Progress reports (for information)

- a) Dog Fouling This appears to have become a significant issue recently. More notices have been put up. Dog Fouling Order 2010 highlights fines and additional notes link to be added to the website to this information. Free notices have been ordered from Keep Britain Tidy campaign, which will help with keeping notices fresh.
- b) Community Park the contract is overrunning slightly. There is an issue with the large climbing frame and this is being sorted out, but causing a slight delay. More donations have been promised from both residents and companies for the project. The fencing contract has been agreed with Fleet Fencing and will start next week. Due to the delay on the main contract liaison with the 2 contractors is required, this is to be facilitated by Mrs R Scott. HAGS-SMP have advised that the park cannot be kept closed for the seeding to take, so the park will be opened and seeded areas taped off. Furniture (benches/tables) is to be installed later, once other work complete and a better feel for the space can be obtained.
- **c)** 71 High Street The order has been placed with Barnards, who are now stripping out, with construction works due to commence 7<sup>th</sup> April.
- **d)** Defibrillators all have now arrived. Installation at William Bailey House to be arranged and Youth & Community Centre. Cricket club to arrange for Dale Field.
- e) LCS store development Meeting with Matt Wilkinson running 1 week late as work in front of Cedar Lodge had to go deeper than anticipated. May be one day when the front entrance needs to be closed. There may be a new notice to be erected, designs to be sent through for approval.

 Existing car park has been ruined by lorries turning for deliveries – this may be an issue once the new car park is completed

- Civil War Centre is coming along nicely. 13<sup>th</sup> April civic reception
- Durhams is having youths break in. The owner is hoping to put in another application for the site.

#### Cllr Mrs M Dobson

- Potter Hill to be refurbished in the 1st Quarter of the new financial year. No central line to be laid but edge lines
- Everyone very pleased with the developments with the library.
- Something new will be moving into the current library space in the Health Centre
- Traffic is being monitored
- Mrs M Dobson concerned about access to the Civil War Centre, especially on a Friday with the traffic problems in Newark.

- Change in Budget code title from Burial Ground to Cemetery Burial Ground is religious and Cemetery is civic. Proposed by Mrs R Scott, Seconded by Mrs V Wright, supported by majority
- Proposal for increase in Cemetery Fees to be reviewed for the period 1 April 2015 to 31 March 2017 – we are reasonably priced, but this is a facility for the people of Collingham or have a connection with Collingham. Proposed by Mrs M Parkin, seconded by Mr T Musson and supported unanimously
- Proposal to order 2 new flags for the village centre Proposed by Mrs R Scott Mrs C Moody and supported unanimously
- Business Rates for the year
  - Cemetery £165.60 1 payment of £21.60 and 9 payments of £16.00 Direct Debit to be arranged, cheque required for initial payment
  - Jubilee Room £244.80 1 payment of £28.80 and 9 payments of £24 Direct Debit set up and in place

- Online Planning Seminar Neighbourhood Plans and Community Engagement. This does not appear to be value for money and it was decided not to take up this offer
- 8. North Collingham War Memorial: English Heritage Possible Listing Any War memorial will be able to obtain more grants if listed. It was therefore proposed that listing of this memorial be pursued by Mrs R Scott, seconded by Mrs V Wright and supported unanimously.
- **9. Best Kept Village** £8 entry fee. Proposed that the village enter the competition again this year by Mrs R Scott, seconded by Mrs V Wright and supported unanimously. Areas to be excluded: LCS development, 60 High Street and Durhams
- 10. Speed Watch Volunteers need to be recruited as reports of speeding have increased recently. If anyone knows anyone who would be interested, please let the Clerk know. Mr C Allen has been asked by a number of local villages for the loan of the equipment. Mr C Allen would like any donations received to be ring fenced for future maintenance of the equipment.
