### MINUTES

**1.0 Apologies:** Cllr's Stammers and Edwards.

**2.0 Minutes:** The minutes of the previous meeting were agreed to be a true record and were signed accordingly.

**4.0 Declarations of Interest:**

Cllr Wright declared an interest in planning at Rooks View. Cllr Dewar-Whalley declared an interest in items 6.1, 6.2, 6.3 and 6.4.

5.1 The chair had attended the recent Garden Party at Buckingham Palace which was a thoroughly enjoyable event.

5.2 Information was given to council regarding the CIL (Community Infrastructure Levy) which has implications for KCC for schools etc.

5.3 Information regarding planning permissions was also given out.

5.4 A letter has been sent to the Boundary Commission.

**6.0 Clerks Report and Correspondence Received:**

6.1 Boundary Commission- a reply has been sent.

6.2 Complaints procedure – Cllr Ball proposed to adopt the complaints procedure, seconded by Cllr Wright with all in favour. This will be placed on the website.

6.3 Code of Conduct- new draft – comments? This was discussed but really there were no comments able to be made. This doesn't require adopting at present.

6.4 Meads Hall update- Cllr Nappey and the clerk gave an update after an informal meeting with the trustees of The Meads Community Hall Trust. They are wishing to build on the original land and it was felt that two halls could compete in this area as they would offer different things. No firm plans were made to meet again although offers of help and advice were given.

6.5 New external auditors- No objections were made to the new auditors.

6.6 KALC Questionnaire- this was completed at the meeting.

6.7 KCC- Minerals & Waste – comments by 23<sup>rd</sup> July- this was taken away and will be responded to in future.

6.9 The insurance required renewing and this was proposed by Cllr Nappey seconded by Cllr Wright with all in favour.
